NOTICE OF HGC AGM: 14 May 2025

The Annual General Meeting of the Hurlingham Glenadrienne Craighall Heritage Foundation NPC (the "HGC") will take place at the

Rosebank Union Church at 18h00 on Wednesday 14 May 2025

At the AGM the board will present their report providing an overview of the HGC projects and achievements during 2024 / 2025 including the financial statements for the year ended 28 February 2025, and details of the projects planned for 2025 / 2026 and beyond.

Ordinary Resolutions

The ordinary resolutions require approval of 50% plus one vote of Members voting on the resolution.

The ordinary resolutions to be passed at the AGM are as follows:

- 1. Approval for increase in the standard rate for contributions o R 1750 made up as follows
 - a. HGC General Contribution R 1 250
 - b. HGC Boom contribution R 500
- 2. Approval of the financial statements;
- 3. Approval of the appointment of external auditors for coming year and approval of remuneration for last year;
- 4. The election of directors;

Further information regarding the appointment of the board of directors in terms of the

MOI, the Board shall comprise at least 3 directors and a maximum of five directors. The Board of directors comprises of the following:

- 2. Raoul Goosen
- 3. Heather Irvine
- 4. Simon Grose

These members have indicated their willingness to continue as Directors for the coming year.

Every Voting Member shall be entitled, by written notice to the HGC to nominate for election him or herself or another Voting Member to the Board. The nomination of any director is to be delivered by such Voting Member to the HGC by email to info@hgccommunity.org at least 7 days prior to the AGM. All nominations are to be received by 7 May 2025.

Financial Statements

A summary of the audited financial statements to 28 February 2025 is attached and will be presented at the AGM. The Audited Financial Statements are available at the registered office of the Company.

Voting at the AGM

According to our MOI, a Voting Member is a Member who makes monthly membership contributions, is not in default of payment of the monthly contributions and has been a Member of good standing for at least 3 months prior to the date upon which the Member wishes to exercise his vote.

Voting at the AGM will be by "show of hands". Any member in good standing is entitled to request a poll on any resolution where it is possible that the outcome may be different to the "show of hands" vote.

Proxy Attendance

A proxy form has is attached with this notice. Any Voting Member is permitted to appoint a proxy should they be unable to attend the meeting in person.

Proxy forms must be handed in before the start of the meeting.

Virtual Attendance

Community members are welcome to join the AGM remotely via Microsoft Teams and to hear and see the presentations made. Interactions with the meeting by virtual attendees will however only be via the chat forum, which will be monitored during the course of the meeting.

Virtual attendees will not be allowed to vote. Proxy forms can be submitted in advance of the meeting if a Voting Member is unable to be present at the meeting.
